

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 5/13/24 – 5/26/24



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **562** calls for service.

LAW ENFORCEMENT ASSISTANCE

On May 13th, an officer on patrol observed a vehicle driving on College Avenue belonging to a 43-year-old Johnson Creek man who was wanted by the Johnson Creek Police Department regarding a Sexual Assault, Battery, and Weapons Violation complaint. A traffic stop was initiated on Packard Avenue just North of College Avenue in the city of Cudahy. The driver was the man wanted for the Johnson Creek incident and he was taken into custody without incident. He was taken to the police department before being turned over to officers from the Johnson Creek Police Department for their investigation.

DISORDERLY CONDUCT

On May 25th, officers were dispatched to an apartment in the 3300 Block of South Chicago Avenue for a report of a resident wanting another individual to leave following an argument. Officers spoke with a 27-year-old South Milwaukee woman and a 29-year-old Racine man who were involved in an argument. During the argument the man pushed the woman into a wall. The man was arrested and taken to the police station before being taken to the Milwaukee County Criminal Justice Facility. He was referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence Related.

On May 15th, officers were dispatched to a residence in the 1200 Block of Monroe Avenue for a report of two individuals involved in an altercation. Officers spoke with a 70-year-old South Milwaukee woman and a 67-year-old South Milwaukee woman who were arguing. During the argument the 67-year-old woman pushed the 70-year-old woman causing her to fall into a dog kennel. The 67-year-old woman was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on a charge of Domestic Violence Battery and Disorderly Conduct Domestic Violence Related.

THEFT

On May 24th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual leaving the store without paying for items. Officers spoke with a 61-year-old Pleasant Prairie man who was in possession of the unpaid for items. The man was also in possession of a pipe commonly used for smoking crack cocaine. He was arrested and taken to the police station where he was issued citations for Retail Theft and Possession of Drug Paraphernalia.

OPERATING WHILE INTOXICATED

On May 24th, officers were dispatched to a business in the 3100 Block of South Chicago Avenue for a report of an individual who fell asleep while in the checkout line and was now attempting to drive away. Officers located a 52-year-old Milwaukee man asleep and hunched over a vehicle with the driver's door open. The man showed signs of impairment and drug paraphernalia was visible in the vehicle. Surveillance video showed the man driving the vehicle to the store. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense, Possession of Drug Paraphernalia-Cocaine, and Possession of Drug Paraphernalia-Marijuana.
