

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 5/27/24 – 6/9/24**

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **457** calls for service.

### **DISORDERLY CONDUCT**

On May 28<sup>th</sup>, officers were dispatched to a residence in the 900 Block of Minnesota Avenue for a report of an individual acting disorderly and causing problems. Officers spoke with a 58-year-old South Milwaukee woman who stated a 36-year-old man threw water on her and pushed her. Both individuals resided at the residence and were related. The man was shouting loudly and continued to shout obscenities after being warned not to. He was arrested and issued a citation for Disorderly Conduct. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on domestic violence charges. On May 30<sup>th</sup>, officers were dispatched to the residence again as the man had returned in violation of a no-contact order. The man was again loud and boisterous to officers. He was arrested and issued a citation for Disorderly Conduct before being taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Bail Jumping.

### **TRESPASS**

On June 2<sup>nd</sup>, officers were dispatched to 200 Block of Southtowne Drive for a report of an unwanted individual at an apartment. Officers spoke with a 38-year-old South Milwaukee man who wanted a 61-year-old Milwaukee man to leave the apartment. The Milwaukee man was previously trespassed from the apartment on June 1<sup>st</sup>. He was arrested and taken to the police station where he was issued a citation for Trespassing.

On June 6<sup>th</sup>, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an intoxicated individual an intoxicated individual yelling at people. Officers spoke with a 33-year-old South Milwaukee man who had been previously trespassed from the store. The man also confirmed warrants with the South Milwaukee Police Department. He was arrested and taken to the police station. He was issued a citation for Trespassing and signed personal recognizance bonds with a new court date on the warrants.

## **THEFT**

On June 7<sup>th</sup>, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual attempting to leave without paying for items. Officers spoke with a 49-year-old Cudahy man who store security observed select a sports hat from a shelf, remove the tags, and attempt to wear it out of the store without paying. He was arrested and taken to the police station where he was issued a citation for Retail Theft.

## **OPERATING WHILE INTOXICATED**

On June 3<sup>rd</sup>, officers located individuals arguing outside a vehicle parked in the lane of traffic in the 900 Block of Marshall Avenue. Officers spoke with a 61-year-old South Milwaukee man who was by the open driver's door of the vehicle and a 53-year-old South Milwaukee woman who was on the passenger side. The man admitted to driving the vehicle prior to the two of them being involved in the verbal argument. He showed signs of impairment and he was arrested for Operating While Intoxicated. He was issued a citation for Improper Parking/Standing of a Vehicle and was taken to the Milwaukee County Criminal Justice Facility where he was referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated- Third Offense.
