

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/10/24 – 6/23/24

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **681** calls for service.

SUSPICIOUS ACTIVITY

On June 23rd, officers were dispatched to the 700 Block of Marshall Avenue for a report of an individual with a backpack walking through yards who appeared to be under the influence of narcotics. Officers located a 39-year-old Milwaukee man who matched the description given. The man was found to be on active parole for burglary. Suspected narcotics were located in a nearby yard and drug paraphernalia was located in the man's backpack. The man was arrested and taken to the police station where he was issued a citation for Possession of Drug Paraphernalia.

TRESPASS

On June 15th, officers were dispatched to the 3300 Block of Marina Road for a report of an individual attempting to open apartment doors. Officers spoke with a 31-year-old Oak Creek man who matched the description given. The man claimed he was in the area looking for apartments. He was found to have been previously trespassed from the same apartment on June 5th. While officers were speaking with the man, he ran away in an attempt to flee the area. He was apprehended a short while later and was arrested and taken to the police station. The man was issued citations for Disorderly Conduct, Resisting Arrest, and Trespassing.

DISORDERLY CONDUCT

On June 13th, officers were dispatched to a restaurant in the 2700 Block of South Chicago Avenue for a report of an individual passed out on the patio. Officers spoke with a 48-year-old Milwaukee man who was intoxicated and incoherent. He was arrested and taken to the police station where he was issued a citation for Disorderly Conduct. He was released after he sobered up.

THEFT

On June 13th, officers were dispatched to a business in the 2900 Block of South Chicago Avenue after employees reported a male removed store items from their packaging while in the bathroom and left without paying for them. Officers located a 35-year-old Milwaukee man who matched the description given at a nearby bus stop. The man was in possession of the missing store items and narcotics and drug paraphernalia were also located in his possession. He was arrested and issued citations for Retail Theft and Possession of Drug Paraphernalia. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on a charge of Possession of Cocaine.

OPERATING WHILE INTOXICATED

On June 20th, an officer on patrol in the 1100 Block of Columbia Avenue was behind a vehicle with license plates that listed to another vehicle. The officer observed the vehicle make an improper turn and then drive erratically in the 1700 Block of Drexel Boulevard before conducting a traffic stop in the 1800 Block of Mackinac Avenue. The driver, a 35-year-old Oak Creek woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated, Improper Display of License Plates, No Proof of Insurance, and Improper Turn. She was released to a sober responsible adult.
