

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/24/24 – 7/7/24

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **497** calls for service.

DISORDERLY CONDUCT

On June 24th, officers were dispatched to the 500 Block of Madison Avenue for a report of an individual arguing with people outside a business. Officers located a 34-year-old South Milwaukee man who was arguing with a 31-year-old South Milwaukee man. The 34-year old man was intoxicated and was located asleep on the sidewalk by the 31-year old man. When the 34-year-old man awoke and began to walk away he left his shoes. When the 31-year-old tried to return them, the 34-year-old pushed him and began to argue. The 34-year-old man was arrested and taken to the police station where he was issued a citation for Disorderly Conduct.

On July 1st, officers were dispatched to a business in the 2900 Block of South Chicago Avenue for a report of an individual involved in a disturbance with an employee. Officers located a 31-year-old Milwaukee woman nearby who matched the description given. The employee recognized the woman as being trespass from the business following an earlier retail theft and told her to leave. As she was leaving she threw the employee's phone on the ground. Officers recognized the woman from a prior retail theft complaint from another business. The woman was also found to be on probation and Probation and Parole requested a hold be placed on her. She was arrested and taken to the police station where she was issued a citation for Disorderly Conduct. She was then taken to the Milwaukee County Criminal Justice Facility on the probation hold.

VEHICLE THEFT

On July 6th, a resident reported a 2022 Jeep was stolen from outside a residence in the 1400 Block of Lakeview Avenue. On July 9th, officers from the Glendale Police Department pursued the vehicle and arrested a 22-year-old Milwaukee man who was driving the vehicle. A stolen firearm and narcotics were located in the vehicle. An investigation revealed evidence that placed the 22-year-old man in the 1400 Block of Lakeview Avenue on the date and time the theft occurred. He was charged by the Milwaukee County District Attorney's Office with First Degree Recklessly Endangering Safety, Drive or Operate Vehicle Without Owner's Consent, Possession of Narcotic Drugs, Felon in Possession of a Firearm, Fleeing or Eluding an Officer, Battery to a Law Enforcement Officer, and Resisting or Obstructing an Officer.

OPERATING WHILE INTOXICATED

On July 7th, an officer on patrol observed a vehicle traveling at a high rate of speed cross the center line and a traffic stop was initiated in the 3300 Block of Nicholson Avenue. The driver, a 28-year-old Racine man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-Third Offense, Reckless Driving, and Operating After Suspension. He was taken to the Milwaukee County Criminal Justice Facility.

WARRANT ARREST

On July 3rd an officer on patrol observed a vehicle traveling above the posted speed limit and a traffic stop was initiated near Nicholson and Elm Avenues. The driver, a 31-year-old Milwaukee woman, was found to have a confirmed warrant with the Ozaukee County Sheriff's Office. The woman became uncooperative and refused to exit the vehicle. She was escorted out of the vehicle and placed under arrest on the warrant. The vehicle was locked and parked and the woman was taken to the Milwaukee County Criminal Justice Facility to be turned over to deputies from the Ozaukee County Sheriff's Office on the warrant.
