

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 6/24/24 – 7/7/24



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **532** calls for service.

WARRANT ARREST

On July 14th, an officer on patrol observed a vehicle fail to stop for the flashing red traffic signal at 17th and Rawson Avenues. A traffic stop was initiated in the 1300 Block of Rawson Avenue and the officer spoke to the driver, a 23-year-old Mayville woman. The woman was found to have a confirmed warrant with the Wisconsin Department of Corrections for a probation violation. The woman was arrested on the warrant and taken to the police station. She was a citation for the flashing red light violation and taken to the Milwaukee County Criminal Justice Facility on the warrant.

DISORDERLY CONDUCT

On July 19th, officers were dispatched to a residence in the 1200 Block of Milwaukee Avenue for a report of a male and female arguing. Officers spoke with a 39-year-old South Milwaukee woman who stated a 56-year-old South Milwaukee man pushed her into a wall. The man initially refused to identify himself and became uncooperative with officers. He was eventually arrested and taken to the police station. He was taken to the Milwaukee County Criminal Justice Facility and referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct-Domestic Violence Related and Resisting or Obstructing an Officer.

OPERATING WHILE INTOXICATED

On July 10th, an officer on patrol observed a vehicle traveling above the speed limit and tailgating other cars near North Chicago and Carrington Avenues. A traffic stop was initiated in the 600 Block of North Chicago Avenue and the officer spoke with the driver, a 21-year-old South Milwaukee man. The man showed signs of impairment and ran from the scene as officers were speaking with him. He was apprehended a short time later and arrested. He was taken to the Milwaukee County Criminal Justice Facility and charged by the Milwaukee County District Attorney's Office with Operating While Intoxicated-Third Offense and Resisting or Obstructing an Officer. He was issued a citation for Operating After Revocation.

THEFT

On July 13th, officers were dispatched to a business in the 200 Block of North Chicago Avenue for a report of an individual failing to scan items and pay for them. Officers spoke with a 36-year-old Milwaukee man, who employees identified as being involved in previous theft prior to this incident. The man was arrested and taken to the police station where he was issued a citation for Retail Theft.

On July 13th, an officer investigating a separate call at a business in the 200 Block of North Chicago Avenue noticed an individual leaving the store with several unpaid for items concealed in his clothing. The officer stopped the individual, a 35-year-old Milwaukee man, who he had recognized from a previous retail theft incident at another business. The man admitted to taking the items and not paying for them. He was arrested and drug paraphernalia was also located in one of his pockets. He was taken to the police station and issued citations for Retail Theft and Possession of Drug Paraphernalia-Cocaine.
