

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 8/5/24 – 8/18/24

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past two weeks the South Milwaukee Police Department responded to **490** calls for service.

DISORDERLY CONDUCT

On August 14th, officers were dispatched to a residence in the 1800 Block of Rawson Avenue for a report of an individual with a weapon threatening to shoot someone. Officers spoke with a 76-year-old South Milwaukee man who yelling about trash being left in the hallway but denied having a weapon. The man was carrying a glass of alcohol and was found to be on parole for felony convictions with a condition being absolute sobriety and no possession of alcohol. Officers obtained a search warrant for the residence and located a revolver inside. Probation and Parole placed a hold on the man and he was arrested and taken to the Milwaukee County Criminal Justice Facility. He was referred to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct While Armed and Felon in Possession of a Firearm.

On August 5th, officers were dispatched to the 700 Block of Monroe Avenue for a report of a disturbance involving two individuals. Officers spoke with a 24-year-old South Milwaukee woman who stated a 35-year-old South Milwaukee woman was yelling outside her residence before kicking and damaging her door. Officers observed a piece of the wooden door frame lying on the floor. The 35-year-old woman accused the 24-year-old woman of taking make-up from her purse. No make-up products were located in the residence. The 35-year-old woman continued to shout profanities and she was arrested. She was taken to the police station where she was issued citations for Disorderly Conduct and Criminal Damage to Property.

On August 15th, officers were dispatched to the 1600 Block of Nicholson Avenue for a report of individuals involved in an argument. Officers spoke with a 36-year-old South Milwaukee man who stated he was arguing with a 29-year-old South Milwaukee woman when she damaged furniture items. Officers located a damaged nightstand at the bottom of stairs at the residence. The woman admitted to throwing the nightstand down the stairs. She was arrested and taken to the Milwaukee County Criminal Justice facility before being referred to the Milwaukee County District Attorney's Office on a charge of Disorderly Conduct-Domestic Violence Related.

DRUG INVESTIGATION

On August 17th, members of the South Shore Joint Tactical Unit executed a signed residential search warrant in the 1200 Block of Milwaukee Avenue. As a result of the warrant, large amounts of illegally obtained prescription medication, Methamphetamine, Cocaine, and Fentanyl were confiscated and a 29-year-old South Milwaukee man and a 23-year-old South Milwaukee woman were arrested. The man was found to be out on bail on a previous Milwaukee County drug case and the woman was found to be out on bail from a previous Washington County drug case. They were taken to the Milwaukee County Criminal Justice Facility and both were charged by the Milwaukee County District Attorney's Office with Possession With Intent to Deliver-Cocaine, Possession With Intent to Deliver-Methamphetamine, Possession With Intent to Deliver-Fentanyl, Possession With Intent to Deliver-Schedule IV Narcotics, and Felony Bail Jumping.

OPERATING WHILE INTOXICATED

On August 10th, an officer on patrol observed a vehicle cross the center-line and drive erratically near Marquette and South Chicago Avenues. The vehicle drove through an alley before stopping in the 1200 Block of Manitowoc Avenue where the officer observed the driver exit the vehicle and stumble. The officer spoke with the driver, a 44 –year-old South Milwaukee man, who showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense, Operating Left of Center and Operating Without Carrying a License. He was released to a sober, responsible adult.
