

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *3/25/19 – 3/31/19*

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past week the South Milwaukee Police Department responded to **238** calls for service.

DISORDERLY CONDUCT

A 36 year old South Milwaukee man was issued a citation for Disorderly Conduct after officers were dispatched to a report of a man yelling loudly from a residence in the 1800 Block of Rawson Avenue just after 4:30 am on March 28th. Officers made contact with the man who admitted he had been yelling and due to his being warned on a similar complaint a few days earlier, he was issued a citation.

Officers were dispatched to a report of a physical disturbance at a residence in the 200 Block of North Chicago Avenue on March 29th. Upon arrival, officers observed a truck leaving the residence and this vehicle was stopped a few blocks away. The driver, a 29 year old South Milwaukee man, showed signs of impairment and was arrested after a brief struggle. He was issued citations for Operating While Intoxicated-First Offense and was taken to the Milwaukee County Criminal Justice Facility for referral to the Milwaukee County District Attorney's Office on charges of Disorderly Conduct-Domestic Violence Related and Resisting/Obstructing Arrest.

Officers were dispatched to a report of individuals arguing outside a residence in the 1600 Block of Clark Ct. on March 30th. Officers located a 30 year old South Milwaukee woman and a 30 year old Milwaukee man who continued to yell at each other. Both were issued citations for Disorderly Conduct and the Milwaukee man was released on a Personal Recognizance Bond for a warrant with the Oak Creek Police Department.

RETAIL THEFT

A citizen reported a man urinating in a parking lot in the 2900 Block of South Chicago Avenue on March 26th. Employees of a store in the area reported the same man left the store without paying for a bottle of alcohol. Later in the evening, officers were dispatched to a suspicious person call in the 1200 Block of Rawson Avenue and located a 48 year old South Milwaukee man matching the description from the earlier incident with a half empty bottle of alcohol. The man admitted to taking the alcohol and he was arrested and issued citations for Disorderly Conduct and Retail Theft.

WARRANT ARREST

A 37 year old South Milwaukee woman was arrested on a confirmed warrant with the Oak Creek Police Department following a traffic stop in the 1000 Block of North Chicago Avenue on March 28th. The woman posted bond on the warrant and was released.

A 23 year old Milwaukee man was arrested on a confirmed warrant with the West Allis Police Department as well as a Probation Violation after officers were dispatched to a report of a vehicle blocking a parking lot exit in the 2900 block of South Chicago Avenue on March 31st. The man was taken to the Milwaukee County Criminal Justice Facility on the warrants.
