

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 4/8/19 – 4/14/19

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)



The past week the South Milwaukee Police Department responded to **265** calls for service.

LAW ENFORCEMENT ASSISTANCE

Officers searched the 1000 Block of Milwaukee Avenue on April 13th for an individual wanted by the Milwaukee Police Department on a temporary felony warrant for Armed Robbery. The subject of the warrant, a 49 year old South Milwaukee woman was arrested and taken to the police station where she was turned over to Milwaukee Police Department personnel.

A 35 year old South Milwaukee man was arrested on a confirmed warrant with Probation and Parole in the 700 Block of Madison Avenue on April 8th. The man was taken to the Milwaukee County Criminal Justice Facility on the warrant.

CRIMINAL DAMAGE

A South Milwaukee woman reported tires slashed on her vehicle and a Janesville man reported tires slashed and windows broken on his vehicle in the 1300 Block of Milwaukee Avenue on April 12th. An investigation is ongoing as officers continue to locate and interview involved persons while also investigating a related assault complaint.

A South Milwaukee woman reported damage to her vehicle caused by paint in the 3100 Block of 5th Avenue on April 9th. The incident is currently under investigation in an attempt to identify a suspect or suspects.

A South Milwaukee man reported the rear window on his vehicle was damaged in the 1900 Block of 18th Avenue. The damage is thought to have occurred sometime between 6:15pm on April 10th and 5:55pm on April 11th. The incident is currently under investigation in an attempt to identify a suspect or suspects.

RETAIL THEFT

Officers were dispatched to the 200 Block of North Chicago Avenue for a report of a female leaving a store without paying for merchandise. An investigation revealed the female concealed 14 cans of baby formula and when confronted by employees returned 10 cans before exiting the store and leaving in a vehicle. An officer observed a vehicle that matched the description and conducted a traffic stop in the 6000 Block of Pennsylvania Avenue in the city of Cudahy. The cans of baby formula were located in the vehicle and the driver, a 29 year old Milwaukee woman was arrested and issued a citation for Retail Theft-2nd Offense. The woman was also issued a citation for Disorderly Conduct as she had been banned from entering the store chain due to previous retail thefts.

Officers were dispatched to a store in the 2900 Block of South Chicago Avenue for a report of a man attempting to return an umbrella that he took from a rack in the store and never paid for. A 39 year old Milwaukee man was arrested and issued a citation for Disorderly Conduct after security video showed him entering the store without the umbrella and an audit of the umbrellas inside the store showed one was missing. The man later stated he was conducting an experiment to see if store security would catch him.
