

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY *4/15/19 – 4/21/19*



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **287** calls for service.

WARRANT ARREST

Officers were dispatched to a report of an intoxicated female yelling in the 1800 Block of Milwaukee Avenue just before 5:00 am on April 18th. Upon arrival, a 34 year old Milwaukee woman stated she had gotten into an argument with friends who pulled her out of their vehicle and left the area. An identification check revealed confirmed warrants for the woman with the South Milwaukee and Cudahy police departments. She was arrested and taken to the Milwaukee County Criminal Justice Facility on the warrants.

A 35 year old South Milwaukee man was arrested on a confirmed warrant with Probation and Parole in the 700 Block of Madison Avenue on April 20th. The man was taken to the Milwaukee County Criminal Justice Facility on the warrant.

DISORDERLY CONDUCT

Officers were dispatched to a report of two men arguing in the 200 Block of North Chicago Avenue on April 19th. A 55 year old Cudahy man stated he was attempting to turn in his vehicle and had to stop to yield to another vehicle when a 21 year old South Milwaukee man on a bicycle began to shout at him for stopping in a crosswalk. The Cudahy man claimed he exited his vehicle when the South Milwaukee man spit into the car, and they continued to argue. Both were issued citations for Disorderly Conduct.

Officers were dispatched to a report of a man stealing a can of soda and threatening customers at a business in the 2300 Block of 10th Avenue on April 19th. An intoxicated 37 year old South Milwaukee man swore at officers and refused to leave the scene. The man was also in possession of a marijuana pipe. He was arrested and taken to the police station where he was issued citations for Disorderly Conduct, Retail Theft, Trespassing, and Possession of Drug Paraphernalia.

TRAFFIC COMPLAINT

An officer observed a vehicle traveling at a high rate of speed in the 1200 Block of North Chicago Avenue on April 18th. The vehicle then made a turn onto Sycamore Avenue where it struck the curb and lost a hubcap before coming to a stop. The driver, a 23 year old South Milwaukee man, was arrested and issued citations for Reckless Driving and Unreasonable and Imprudent Speed.

FIRE

Following up on an observation of smoke coming from behind a building in the 1900 Block of 12th Avenue on April 20th, an officer located a brush fire near the railroad tracks. South Milwaukee Fire Department personnel responded to extinguish the fire and no structures were damaged. Another officer observed two individuals running from the area and detained them in the 2400 Block of South Chicago Avenue. The individuals, a 17 year old South Milwaukee boy and a 13 year old South Milwaukee boy, admitted to accidentally starting the fire while lighting fireworks. A marijuana pipe and marijuana were also located in a backpack owned by the 13 year old. The 17 year old was issued citations for Negligent Handling of Burning Materials, Fireworks, and Juvenile Possession of an Ignition Device while the 13 year old was issued citations for Negligent Handling of Burning Materials, Fireworks, Juvenile Possession of an Ignition Device, and Possession of Marijuana and Possession of Drug Paraphernalia.
