

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY *5/4/20 – 5/17/20***

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past two weeks the South Milwaukee Police Department responded to **330** calls for service.

### **DISORDERLY CONDUCT**

On May 12<sup>th</sup>, officers were dispatched to a report of an argument between individuals in the 1100 Block of Marion Avenue. Officers arrived on scene and spoke with a 20-year-old South Milwaukee woman, a 27-year-old Milwaukee man, and a 36-year-old Cudahy woman. The argument began when the Milwaukee man, who was visiting the South Milwaukee woman, requested the Cudahy woman to turn down the music in her car. The Cudahy woman was alleged to have threatened the other two with a knife and the South Milwaukee woman reportedly sprayed pepper spray at her. Both women were issued citations for Disorderly Conduct.

On May 16<sup>th</sup>, officers were dispatched to the 1200 Block of Missouri Avenue for a report of individuals fighting in the alley. Officers located a 26-year-old Milwaukee man attempting to leave the scene in a vehicle and a 29-year-old South Milwaukee man who was uncooperative. It was determined the two were involved in an altercation and both were arrested. The South Milwaukee man was issued citations for Disorderly Conduct and Resisting while the Milwaukee man was issued citations for Disorderly Conduct and Operating After Revocation.

## **BATTERY**

**On May 11<sup>th</sup>, officers were dispatched to the 2900 Block of South Chicago Avenue for a report of a female being struck by a male. Officers spoke with a 36-year-old Milwaukee woman who reported a 35-year-old Milwaukee man struck her and fled the area on a bus. The Milwaukee County Transit System was contacted and with the assistance of officers from the Cudahy Police Department, the bus was stopped in the city of Cudahy. Officers located the Milwaukee man on the bus and he was arrested and taken to the Milwaukee County Criminal Justice Facility before being referred to the Milwaukee County District Attorney's Office on Domestic Violence Battery charges.**

## **OPERATING WHILE INTOXICATED**

**On May 11<sup>th</sup>, officers were dispatched to the 3100 Block of South Chicago Avenue after a 911 call was received with an open line. Upon arrival to the area, officers spoke with a 42-year-old Oak Creek man who appeared agitated and showed signs of impairment. A vehicle was located against a pole in the area and the man admitted to driving the vehicle and consuming drugs. A South Milwaukee Fire Department ambulance responded to transport the man to a hospital for treatment. Once cleared from the hospital, the man was issued citations for Operating With a Controlled Substance and Resisting before being released to a sober responsible adult.**

**On May 15<sup>th</sup>, officers were dispatched to the 700 Block of Edgewood Avenue for a report of a motorcycle striking a tree. Upon arrival, officers spoke with a 53-year-old South Milwaukee man who stated he lost control of his motorcycle. The man showed signs of impairment and South Milwaukee Fire Department personnel responded to the scene to tend to his possible injuries. The man was taken to a hospital for treatment and was later issued citations for Operating While Intoxicated-3<sup>rd</sup> Offense and Operating a Motorcycle Without a Valid License.**
